ARAPITO LODGE - NOW AVAILABLE

How time has moved on. In Greenplan's Newsletter "February 1999" we officially opened the Arapito Lodge. The purpose of the lodge was to provide pruning contractors with superior accommodation closer to the forests where work was being undertaken. Now that most of the work in close proximity to the lodge has been completed the pruners requirements for accommodation have ended. This has led us to reconsider the use of the lodge. The obvious solution

is to offer the lodge to investors and other members of the public as a holiday escape.

The Lodge

A near new 7 bedroom fully self contained lodge capable of sleeping 13 guests, located some 35 kilometres southeast of Te Kuiti on the Mapara South Road.

The lodge is situated in the Aratoro Valley adjacent to the Mapara Wildlife Reserve, Greenplan Forests and Farmland. They offer endless hours of walking, bird watching or just simple relaxation.

The Aratoro Valley:

A picturesque tranquil hideaway. Located on a 12km no exit gravel road approx. 30 minutes drive south east of Te Kuiti.

The valley redefines the meaning of peace and quiet with the only interruption to the peace and solitude being the songs of the birds.

The Mapara Wildlife Reserve:

Some 1400 hectares of native bush, the reserve has been the focal point for saving the endangered Kokako. This is one of New Zealand's most ancient birds and belongs to the wattlebird family. The Kokako is world renowned for its beautiful song. For those of you interested in birdlife the Mapara Reserve offers the real possibility of seeing and listening to the Kokako firsthand. The best time to see and hear the birds is at dawn or dusk.

Exotic Forests:

This is the valley where Greenplan was conceived. To date some 1000 hectares of Radiata pine is growing there. Endless opportunities for walks and exploring. Added attraction if you are a partner in one of the surrounding forests.

RECENT EVENTS:

Pest control is an important aspect of Forest Management. With the departure in November of our property manager we had a timely approach by a recreational hunting company, Ranginui Hunting Limited. Founder Mark Brough has offered to undertake all pest control activities on the Greenplan Forests south of Te Kuiti. With this introduction we also saw an opportunity for Mark and his team to manage the Greenplan Investors hunting requirements.

Our previous hunting policy was based around a permit system. Hunters wanting to try their luck requested an annual permit which once granted allowed access into the forest blocks. As at December 10th 2004 the permit system remains and all recreational hunting visits are to be co-ordinated through Ranginui Hunting. For investors there is no charge and the hunting is on a first in first serve basis. To make a booking you will need to contact Ranginui Hunting Ltd. Anyone wanting a permit will need to contact Greenplan.

This still left us with the requirement of pest control in the forest blocks north of Te Kuiti. To resolve this we have appointed Kerry Witchell of Te Waitere. Kerry has a vast range of skills and a passion for pest control. He will along with monitoring the forests, undertake the odd maintenance job as arises.

We feel very confident that the pest monitoring program will be kept to the high standard as previously attained by Mark Meredith (our previous property manager).

FOREST MANAGEMENT DIARY

Contractors working in the Greenplan forests have been kept busy during the summer months. While the season is somewhat later than normal for the King Country the trees have experienced excellent growing conditions over the past five months. This we expect to continue into March and April.

Spring rain during November and recently in December has kept the fire risk low throughout the Greenplan estate. We will be relocating contractors to other forests shortly to ease risk in the driest areas. Currently all staff and contractors carry fire fighting equipment. Forests are closely monitored at all times during this time of the year.

All third lift and thinning to waste operations are now completed in the 1996 forests. This is the final operation for these forests. An audit of final stocking and pruned height has recently been completed by forest consultants, P F Olsen & Co Ltd of Rotorua. All forests have achieved the required stocking and pruned height as outlined in the prospectus. The trees will now be left to grow and we will continue to monitor their development closely.

Third lift pruning is ongoing in the 1997 forests. Once pruning is completed the forests are then thinned to waste. This operation involves cutting the unpruned 'followers' down which leaves the pruned crop trees. The followers have accomplished their goal by controlling the growth rate and branch size of the crop trees. Thinning to Waste operations are currently underway in Coach Road No. 30 and will begin in Pig & Whistle No. 34 shortly. These operations are now complete in Arapito No. 28 and Rim Rock No. 33.

We have programmed to begin second lift operations this month. The Jones No. 39 and Huntaway No. 40 forests will be the first to be pruned followed by Boltaway No. 41, Clearwater No. 42 and finally Wild Boar No. 43. The second lift pruning operation involves removing the branches from the tree to approximately 5 metres. The pruning crews carry ladders which they use to achieve the correct pruned height.

First lift pruning is well underway in the 2000 forests. Many forests are now completed, there are a few areas of smaller trees waiting to be pruned after the summer. The 2001 forests are experiencing excellent growth and the pruning programme has commenced earlier than expected. The Dunmore North No. 48 forest is currently being pruned and small areas of pruning in the other forests is expected to begin after the summer.

Many forests were sprayed for Dothistroma pini in November 2004. Dothistroma is a fungus which affects the needles of the tree. It is easily controlled by spraying a copper oxy-chloride mixture over the affected controlled trees. We completed this operation in November using a helicopter. The affected trees are now showing signs of improvement. The fungus is also eliminated by removing infected branch's during the pruning operation. Some small infections, in localised areas of the forest, will be sprayed again in February.

The Wayleggo No. 62 and Scotts Bush No. 63 forests are now well established. There are a few patches throughout which will be sprayed again to kill competing grasses. This is usual in the most fertile parts of farmland. A forest establishment audit will be performed in Autumn.

NEWS CHIPS:

An article we came across showing that forestry investment is still attractive to astute investors.

Forestry Still Attracting Investors - 20/12/2004

Despite the tough challenges facing the New Zealand forestry industry with log exporters being hit by the strength of the Kiwi dollar and soaring freight costs, thousands of individual investors remained convinced that the sector has a worthwhile long-term future.

An article in the latest issue of Inwood, Australasia's biggest circulating wood business magazine, says that investors are moving towards direct investment in small plantation forestry schemes and are unperturbed by the fact that they will have to wait for up to 30 years for a return.

Several such schemes are on offer but the sector is dominated by three: Roger Dickie NZ Ltd, Greenplan Forestry Investments and Forest Enterprises NZ Ltd. Each has the same long term objective but there are distinct differences in the structure of each scheme.

Demonstrating the attractiveness of such forest investments, the article reports that one forest site brought an overall return to investors, including intermediate returns from thinnings, of 20% over the 26-year life of the plantation. [source: www.nzforestry.co.nz]

Also from the same source we found evidence that New Zealand is leading the world in providing a sustainable wood resource.

A RARE STATE

Proportionately, New Zealand has one of the largest areas of protected natural forest in the world - nearly 6 million hectares.

It is also home to the world's biggest and most intensively managed tree plantations - now covering 1.8 million hectares.

Something of a paradox, we agree, but it nevertheless enables New Zealand to truthfully claim that almost all of its industrial wood needs are met from sustainably managed forests.
